

**Agreement of collaboration between Alliance Anti Traffic
and representatives of the media**



Date

This Agreement of Cooperation (referred as AoC) is made between Alliance Anti Traffic (Thailand) by Mr. Jurgen Thomas, International Project Director, with office located at 328/1 Phayathai Rd., Thanon Phetchburi., Ratchatewi, Bangkok, 10400, Thailand (hereinafter referred to as 'Licensor').

And Mr./Mrs./Ms, Position:, With office located at.....

Acknowledging that Alliance Anti Traffic (AAT) works for the protection of women and children and to ensure their best interest is met at all times and that AAT therefore has the responsibility to respect the safety, rights and dignity of the women and children the Organization works with. AAT also has the responsibility to ensure that its project activities in the field are fully in line with target groups' best interest;

Understanding that the problem of human trafficking can only be eradicated with the participation of every sector of society, and the importance of the media community in disseminating information in order to increase participation in the eradication of this problem;

AAT wants to facilitate the dissemination of relevant information in the field of human trafficking and sexual exploitation as far as information is collected and disseminated respecting the safety, rights, and dignity of its target group and without jeopardizing project implementation. In order to ensure that these considerations are taken into account, AAT requires the Licensee to sign the present agreement, thereby agreeing to respect the following points:

1. The Licensee shall conduct interviews, take pictures and film video material only when and where an AAT representative authorizes the Licensee to do so.
2. Taking and/or publishing pictures of faces of (former) victims as well as the publication of their names and/or addresses, as well as those of their relatives, is not allowed.
3. Interviews with (former) victims of other members of AAT's target group should be prepared in advance together with AAT staff, who will obtain a written authorization from the interviewee. Main questions must be sent to AAT staff prior to the interview. Interviews can be undertaken only in the presence of AAT social workers and when interpretation is needed, an interpreter assigned or approved by AAT in order to make sure

that all participants in the interview can be trusted to maintain confidentiality. Follow-up questions can be asked if made sure that questions are in line with what has been agreed between the Licensee and AAT beforehand.



4. Field visits will be conducted together with a facilitator from AAT. When the visit is under the responsibility of AAT, any information disseminated can have a direct impact on the safety of members of AAT's target group or damaging consequences on the implementation of the project visited (especially in countries where project implementation is controlled by the government).
5. The Licensee must send the final product to AAT for final approval before dissemination. AAT has the right to ask for modifications to the content or prohibit its diffusion in the case that AAT representatives think it will have negative consequences on the safety, dignity or the fulfillment of the rights of members of its target group, or on project implementation.
6. The Licensee agrees to fully comply with requirements set out in points 1-5 and understands that modifications to this agreement can only be done with the authorization of the AAT representative accompanying the Licensee on the field trip. If the Licensee fails to respect the AoC, lawsuits can be undertaken.
7. The Licensee agrees to truthfully inform AAT about the publisher(s)/contractor(s) of the product before signing this Agreement. The Licensee will inform AAT of the date(s) and channel(s) of diffusion of the product before its dissemination and/or send a copy of the published product to AAT.
8. The Licensee certifies that AAT's name will be mentioned in the final product unless AAT representatives specifically express the wish to leave out the name of the Organization.
